A PURPOSE

To describe the responsibilities of Investigators who have been assigned an animal room in the Animal Care Facility.

B COVERED PARTIES

This policy applies to Investigators who are listed on an active IACUC protocol and who have been assigned a room in the Animal Care Facility.

C POLICY

Investigators assume the following responsibilities upon being assigned an animal care room:

- 1. Routine cleaning of their assigned animal care room.
 - Regular trash will be placed outside the facilities for pick-up.
 - Biohazard and chemical waste disposal will be arranged with Safety and Risk Management.
 - All sharps will be placed in designated container.
 - Abiding by an approved chemical hygiene plan.
- 1. Routine cleaning of the cage wash room and common areas in facility.
- 2. Notifying the IACUC in the event that facility maintenance is required.
- 3. Ensuring that all students listed on their protocols and visitors that they escort abide by all IACUC policies, SOPS, and posted placards.
- 4. Contacting the UTC Facilities and/or Police Department to notify of facility access after-hours and during university breaks.
- 5. Abiding by all entrance/exit procedures, quarantine procedures, and personal safety requirements.
